INSTRUCTIONS FOR KNOX COUNTY DOG LICENSES:

IT'S THE LAW (ORC 955.01)

All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag.

(The law applies regardless of whether the dog is kept inside or out.)

ON-LINE

Register your dog on-line at http://www.doglicenses.us/OH/Knox. Only credit card payments accepted; \$2.25/license processing fee applies. To access your pre-filled form you will need your Account ID and Password listed below.

IN PERSON OR BY MAIL

Account ID:

- 1. Complete this form. Be sure the correct owner, street address, and pet description(s) appear on all applications.
- Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form. Ohio law requires a license for every dog more than 3 months old.
- If you no longer own the dog(s) please contact our office or mark through the appropriate line below and return the form so we can update our records.
- Enclose a check or money order for the correct fees payable to: Knox County Treasurer. Please do not send cash. Before January 31, licensing rate is \$16.00 per dog; (if operating a kennel the license fee is \$80.00). After January 31, statutory late penalty increases the licensing rate to \$32.00 per dog; (if operating a kennel the license fee is \$160.00). Your application cannot be processed without the correct fees.
- 5. Please return the application and check or money order. A receipt will be returned to you with your 2024 license tag(s).

You may purchase the tag(s) in person at the Knox County Auditor's Office, 117 East High Street, Suite 120, Mount Vernon, or the Knox County Dog Shelter at 285 Columbus Rd, Mount Vernon. Please bring the attached form when purchasing tags at either location.

THREE YEAR TAG

Before January 31, the license rate is \$48.00 per dog. The tag is non-refundable and cannot be transferred to a different dog.
